City Manager Dennis Durham presented the city manager's report and distributed the handout (see official meeting record). Ward-Mullen asked about code enforcement on grass and brush overgrowth, especially for bank-owned, vacant properties. Staff noted there is an abatement process and encouraged Council to direct all code enforcement complaints through Community & Economic Development Coordinator Aimee Amerson for tracking. Discussions followed about proactive verses reactive methods to code enforcement and if Council wishes to discuss changing the current code enforcement program in a future work session.
