### Water

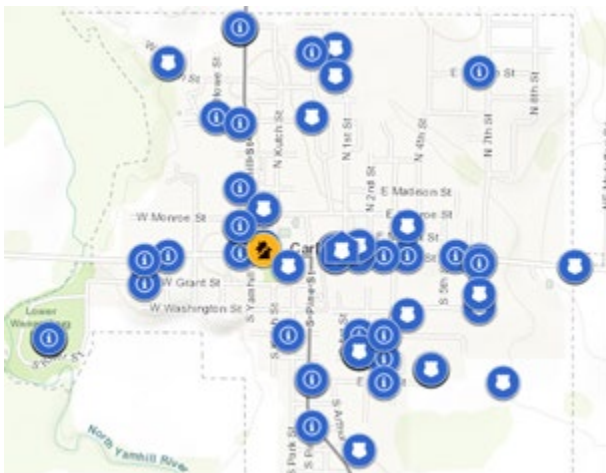
- ◆ Service line work on Meadow Lake Road is approximately 50% complete

## Arrests

On October 18, 2021, Carlton Police Department started an investigation regarding a criminal mischief that occurred near the Carlton Pool. ## The Carlton Code Corner

As the season turns to Spring and the weather warms, the Carlton City Council and the City's dedicated team members would like to remind you that it is a great time to assess your property in order to remain in compliance with the City's code. We will highlight a section of the code weekly to help you in assessing

your property. Carlton code provides the following guidelines for RVs and Trailer Houses:

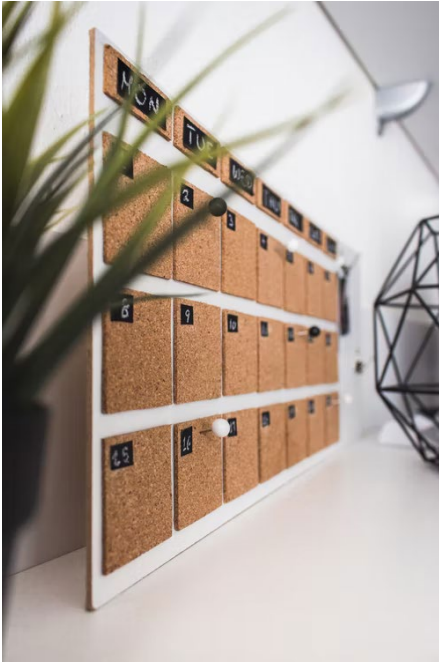
### What is permitted:

- Parking a Recreational Vehicle or Trailer House for a period **up to 72 hours** on public streets while maintaining clear vision and safe passage for cars and pedestrians. After the 72 hours expire, the vehicle or trailer must be moved. Failure to do so may result in citation or towing.
- Recreational Vehicles or Trailer Houses can be parked on private property for an indefinite amount of time if the vehicle or trailer doesn't cause any obstruction of sight or impediment for traffic and no one lives or is temporarily staying in it.
- Camping in a recreational vehicle or trailer house on private property on a temporary basis must be approved by the City of Carlton with a **Temporary** Trailer Parking Permit.

### What is **NOT** permitted:

- Overnight sleeping or living in Recreational Vehicles and Trailer Houses on Public Streets **at any time.**
- Permanent camping/living in a Recreational Vehicle or Trailer House on private property is not permitted.
- Yard areas adjacent to a street are not to be used for the permanent storage of utility trailers, house or vacation trailers.

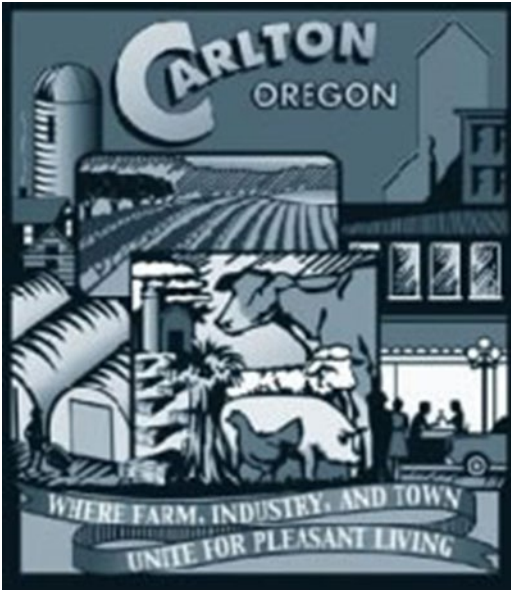
## *Opportunities to Get Involved*

## **We need your Input!**

Oregon is required to establish Total Maximum Daily Loads (TMDL) for streams segments which do not meet water quality standards. The TMDL identifies the level of pollutants that a water body can absorb and still meet water quality standards.

The City of Carlton has both the Yamhill river and Hawn Creek near and through it. It is important to keep these waterways clean for fish and wildlife use. The City will soon begin developing our own required Water Quality Management plan and we need your input. If you could spare a few moments of time and share your thoughts, we would appreciate your time and responses.

## ADA curb ramps Construction in 2022

ODOT is installing ADA compliant curb ramps on the corners of several intersections in Carlton. ODOT plans to construct one corner of an intersection at a time, with up to five intersections under construction at once. When construction starts, expect ODOT crews working during the day and at night as needed.

## OR 47 realignment design is underway
