Several grants from the Oregon Department of Transportation were awarded to Carlton PD to assist with this overall safety effort.



The Carlton Code Corner

Residents and visitors alike are flocking outdoors to chase down some sunshine, this week let's review some of the ordinances for our beautiful city parks:

- Parks are open dawn to dusk except during special occasions as authorized by order of the City Council
- No open fires. Barbeque use is permitted in picnic areas only
- No dogs allowed on sports field and play structure areas in Wennerberg Park. In the Upper Park dogs must be on a leash. Any person failing to clean up after their dog is subject to a five hundred dollar (\$500.00) fine
- Motor vehicles, motorcycles and trailers shall be operated on roadways at the posted speed and park in designated areas
- All park visitors must be polite and respectful, any park visitor using abusive or profane language may be expelled from the Carlton park system
- Vandalism to any city park plants, trees, rocks, soil or structures or other city property will be subject to a minimum fine of five hundred dollars (\$500.00)
- All waste material shall be properly disposed of in the provided receptacles or hauled away by the park user
- Permits are required to put up signs or for the assembly of persons in the city park to which the general public is invited when it is expected that there will be more than ten (10) people attending
- You may not ride horses in the park unless permitted by City Council for a special event
- **Any form of recreation that is determined by city staff to have the potential to harm another park user is prohibited.**

To obtain a permit for a special event or to place a park shelter reservation please call City Hall.

ADA curb ramps Construction in 2022

ODOT is installing ADA compliant curb ramps on the corners of several intersections in Carlton. ODOT plans to construct one corner of an intersection at a time, with up to five intersections under construction at once. When construction starts, expect ODOT crews working during the day and at night as needed. During construction, the project webpage or Tripcheck.com will have the most up to date information about impacts. OR 47 realignment design is underway

You may see activity in Carlton as ODOT restarts the design of the OR 47 realignment project. This project includes installing ADA curb ramps, bike lanes and rerouting traffic to a new alignment of OR 47 from W Main Street onto Monroe Street.
