
Next Summit meeting October 5th at 6PM at the Carlton Legion Hall

#### **Parks and Recreation**

- Ladd Park annual winter maintenance will occur on September 30th
- Safety lighting is being installed at Hawn Creek Park
- All parks are receiving fall maintenance and upgrades including the Wennerberg disc golf course



## **Public Works**

#### <u>Water</u>

- Reservoir dredging has been extended to the end of October
- Water plant has new SCADA set points so we are able to control the water flow more efficiently. SCADA is a supervisory control and data system that allows for efficient monitoring and management
- Security fence and driveway around concrete reservoir complete

#### Sewer

- Hawn Creek Pump station 80% complete
- Lagoon archeological survey is underway
- Aerator upgrade units continue to have good treatment results

#### **Construction**

- Paving is scheduled to be completed on September 30<sup>th</sup> on East Main St
- Status of Public Works Building for city staff move
  - Grading for Modular office/Council Chambers is complete
  - Bins for gravel cold mix is complete and a security fence will be added soon
  - Site storm drainage is complete
  - Next week the water line and excavation will be done for the new building that will temporarily house city staff during construction and then protect public works equipment
- Brooklyn Terrace is 90% complete
- Foundation has been poured on the JR1 apartments

## **Code Corner**

This week we will go over requirements for portable accessory structures. A portable accessory structure is a structure intended for shelter or storage of vehicles, which is self-supported and not permanently attached to a footing or foundation. These requirements ensure compliance with fire codes, public safety, domestic access, proper ventilation and service line access. Let's go over current standards in residential zones. Appearance:

- Anchored
  - Structurally sound
  - Original Manufacturer's coverings
  - NO: plastic sheeting, tarps or other materials are to be used as a covering

#### Location:

- Residential zones
  - Front Yard: 1 structure used as a private garage may be in the side portion of a front yard if setbacks and clear vision standards are met
  - Rear Yard: setbacks must be met
    - Structures 10 feet or less: 5 feet side and rear
    - Structures 10+ feet: 5 feet side and 10 feet rear
      - If the structure exceeds 200 square feet a permit is required

Please remember that structures must meet setback requirements for the underlying residential zone. Visit our website for more information or give us a call at City Hall!

## Carlton Police Department Conducts Pedestrian Safety Crosswalk Enforcement Event

In October 2021, Carlton Police Department received a pedestrian safety enforcement grant from Oregon Impact and Oregon Department of Transportation.

This grant provides funding for pedestrian safety enforcement operations that focus specifically on motorists who fail to yield the right-of-way to pedestrians.

According to the National Highway Traffic Safety Administration (NHTSA), in 2020, 6,516 pedestrians were killed, and an estimated 55,000 pedestrians were injured nationwide.

On September 23, 2022, Carlton Police Department conducted a pedestrian safety crosswalk enforcement event at the intersection of Main Street and Kutch Street in Carlton. During the event, Carlton Police Department conducted eleven traffic stops. Three drivers were issued citations for driving while using a mobile electronic device, and one driver was issued a citation for failing to obey a traffic control device. Four drivers were issued verbal warnings for failing to stop for pedestrians, two drivers were issued verbal warnings for failing to obey traffic control devices, and one driver was issued a verbal warning for an equipment violation.

Carlton Police Department is committed to upholding pedestrian safety laws to protect citizens and encourages pedestrians to use crosswalks when crossing the street, and to look both ways for traffic before crossing, ensuring that vehicles are yielding before crossing. Drivers should stop for pedestrians and remain stopped until the pedestrian has reached the sidewalk.
