Carlton businesses hit hard by burglary spree

Local man arrested, and freed, shortly after break-ins

Charles Johnson was taken into custody for allegedly breaking into eight businesses and an occupied residence in Carlton's downtown core the morning of Tuesday, Dec. 27. He was transported to the Yamhill County Jail where he was processed, released from custody and given a Circuit Court reporting date.

All of which left one of the business owners, Main Street Market & Deli's Tom Bischof, in a state of shock that the 23-year-old Johnson, a Carlton resident, was out of custody soon after Carlton police charged him with eight counts of possession of a burglary tool or theft device, six counts of second-degree burglary and one count each of first-degree burglary and carrying of concealed weapons. The charges are a mix of felonies and misdemeanors.

It was also an attached apartment to his business, where he and his wife Tina's 25-yearold daughter was living, that Bischof said Johnson accessed by breaking through a door.

"My daughter yelled and scared him off," Bischof said.

According to police, in addition to the Main Street Market & Deli, 208 Main St., other businesses victimized by Johnson were Blind Pig, 325 W. Main St.; Bull Run Distillery Carlton Post, 214 W. Main St.; Carlton Corners, 150 N. Yamhill St.; Carlton Market, 335 W. Madison St.; Earth & Sea Restaurant, 209 N. Kutch St.; and Cuvee restaurant, 214 W. Main St.

Bischof said Johnson gained access to his store by breaking through a door leading to the upstairs apartment.

"I was blown away by what happened," he said. "It's beyond words that someone could break into these businesses and a residence and not go to jail. I can't believe he's not in jail. What's this teaching people? It's scary."

Bischof knows not to blame the Carlton police. Officers solved the crimes quickly and charged Johnson and took him to jail, at which time he was set free, in part, because of Senate Bill 48, which went into effect July 1, 2022.

The law eliminated certain mandatory minimum jail conditions and required individualized assessments based on objective criteria when making release determinations and setting security. The bill directs the presiding judge in each judicial district to assemble standing pre-trial release orders, using crime categories as a guide.

Judge Ladd Wiles presides on the Yamhill County bench. Judge Cynthia Easterday was the presiding judge when Senate Bill 48 took effect.

Bischof said after Johnson was identified by Carlton police as a suspect and taken into custody, he walked officers around town, identifying the businesses he had burglarized.

He was not unfamiliar to Bischof.

"The kid came in (to Main Street Market & Deli) regularly," he said. "He was always pretty nice, never disrespectful."

Video surveillance captured Johnson in Bischof's store. He wore a mask. Martinez said he was identified as a suspect, largely in part due to surveillance footage and "other investigative leads."

Martinez asserted that the primary objective of the break-ins was to obtain cash to support a fentanyl habit.

"It was not a significant amount of cash, and other items of value were not disturbed," Martinez said.

Most of the locations were accessed with what Martinez described as a "pry tool" that damaged entryways. One business had the front door glass shattered. Johnson is scheduled to be arraigned on the charges in circuit court at 1:30 p.m. Wednesday, Jan. 11.

Martinez, the Carlton chief since 2012, said he's never seen so many burglaries in one night during his years leading the police department.

"We rarely have burglaries of businesses or residential homes in the city," he said.

Between 2019 and 2022, he said there were about 40 burglary-related reports, including the most recent spate, of which only about 23 turned out to be what he classified as valid cases.

In light of these recent burglaries, Carlton Police will host a business/home safety presentation in the near future in order to help property owners avoid such a thing from happening in the future.

"Prevention of these crimes takes the partnership and preventative actions of community members, businesses and police, each doing their part to work together in order to minimize and reduce criminal activity," Martinez said.

The date, time and location of the event will be announced when the plan is solidified.
