Weekly Report

Our Public Works Crew has been working hard up at the Water Plant, calibrating pumps and maintaining the equipment that provides water to Carlton's citizens.

Did you know that Carlton's drinking water supply is conveyed from Panther Creek Reservoir which is approximately 8 miles west of town? The water is treated at the City of Carlton's Water Treatment Plant, which is located on Panther Creek Road. The water is then gravity fed into two elevated water storage tanks. These tanks provide water pressure to over 5 miles of mains from 4" to 12" in diameter.

The city water tanks and treatment plant are all tied into a single computer monitoring system. This system monitors the water tank levels, flow rates and treatment output.

Public Works staff maintains the entire water system including monitoring treatment processes, testing water purity and providing results to state agencies, monitoring tank levels, repairing water mains, repairing and testing water hydrants, and installing and reading water meters.

Code Corner

There are two types of Business Licenses that the city processes:

Temporary Licenses and Annual Licenses. Today we will discuss the how and why Temporary Licenses are important.

Remember that:

One act constitutes doing business, this includes:

- ✦ Selling goods or services within the city
- Soliciting business within the city
- Displaying signs that offer goods or services
- Using any vehicle or premises in the city in business resulting in profit.

Temporary Licenses are required for any business within city limits, including: pop-up shops, event vendors and door to door sales.

Exemptions include:

- "Garage Sales"
- Leasing or renting fewer than two separate units, spaces or parcels of property
- Delivery within the city from businesses outside the city
- Home or personal care
- Non-profits
- Part-time babysitting, nursery or child-care
- + Intermittent/Casual employee rendering services to a household
- + Contractor/Landscape Contractor with a state license and business located outside the city

A business license for in City use, can be issued for 6 months or less for a fee of \$25.

This temporary business license policy is in place to protect the citizens of Carlton by deterring out-of-town scammers from trying to make a quick sale on un-suspecting customers. Travelling contractors and sales scams from out of state merchants have been rampant in the last few years.

Please contact City Hall if you need to report an unlicensed transient merchant or door-to-door representative so we can reach out and supply directions to obtain a temporary business license.
