



RESOLUTION NO. 2016-221

A RESOLUTION ADOPTING AMENDED WATER RATES FOR THE CITY OF CARLTON WATER SYSTEM

RECITALS:

WHEREAS, Carlton Municipal Code Chapter 13.04.271 governs the adoption of city water rates, fees and charges by the City Council of the City of Carlton; and

WHEREAS, the City Council has contracted with utility systems financial consultant Deb Galardi, to review and make recommendations regarding City of Carlton water system service rates and system attributes, including the water system Capital Improvement Program, system operating and maintenance costs and compliance with projected debt service coverage requirements; and

WHEREAS, the financial consultant has recommended, based on her analysis of current and future anticipated water fund needs, that the City Council adopt a revised schedule of existing monthly water charges reallocating monthly charges between different classifications of water users of the City of Carlton water system.

THE CITY OF CARLTON RESOLVES AS FOLLOWS:

1. Effective as of April 1, 2016, all current monthly water service rates and charges for the City of Carlton, Oregon, shall be amended to those certain classifications and amounts set forth on Exhibit A attached hereto and made a part hereof .
2. This resolution shall take effect immediately upon its passage by the City Council and execution by the Mayor.
